**POWER OF ATTORNEY

Nancy Schneider, Principal, to HELEN JAKUBCZYK, Attorney in Fact, made under Indiana Code 30-5, as it may be amended or replaced (the "Statute").

I, as principal, designate and name the person whose name appears above to be my attorney in fact.

A. Powers. According to the Statute, an attorney in fact has a power granted under IC 30-5 if the power of attorney incorporates the power. Therefore, by referring to the language of the Statute describing powers, this Power of Attorney incorporates into the power here listed and confers general authority with respect to it:

1. Real Property. Authority with respect to real property transactions pursuant to IC 30-5-5-2; and, specifically, in relation to the following described real estate:
