RIGHTS OF THE TRUSTOR:

(1) Trustor reserves the rights to revoke or amend this Trust without notifying any Beneficiary or Trustee. All amendments to this Trust shall be in writing, upon proper forms and made a part hereof.

(2) Trustor reserves the right to appoint or otherwise change the person appointed as Trustee without prior notice.

- (3) Trustor reserves all rights to designate or otherwise change the persons designated as Beneficiaries without prior notice.
 - (4) Trustor retains all rights to all income from the Trust Property.
- (5) In the event the Trustor becomes physically or mentally incapacitated, as certified by a competent attending medical authority, the Successor Trustee shall administer this Trust to the benefit of the Trustor. The power and authority granted the Successor Trustee under this paragraph shall be terminated when the Trustor is sufficiently recovered, as certified by a competent attending medical authority, to resume administration of this Trust.
- (6) This Trust shall be administered for the sole benefit of the Trustor during her lifetime.

(7) Upon the death of the Trustor, this Trust becomes irrevocable and may not be modified except as specifically authorized by this document.

RIGHTS AND DUTIES OF TRUSTEE:

- (1) The term "Trustee" shall apply to any Trustee or Successor Trustee.
- (2) Trustees rights and duties shall apply to the Maria Sedlak Trust.
- (3) The Trustee shall have all authority and power to administer this Trust in accordance with the laws of the State of Indiana.
- (4) The Trustee's authority and power shall include, but is not limited to the power to buy, sell, pledge, option, mortgage, or otherwise encumber this Trust Property for the benefit of the Trust.
