6. At the time of the death of Nellie C. Clinton, she had been preceded in death by her husband, Earl W. Clinton, and was survived by the following children:

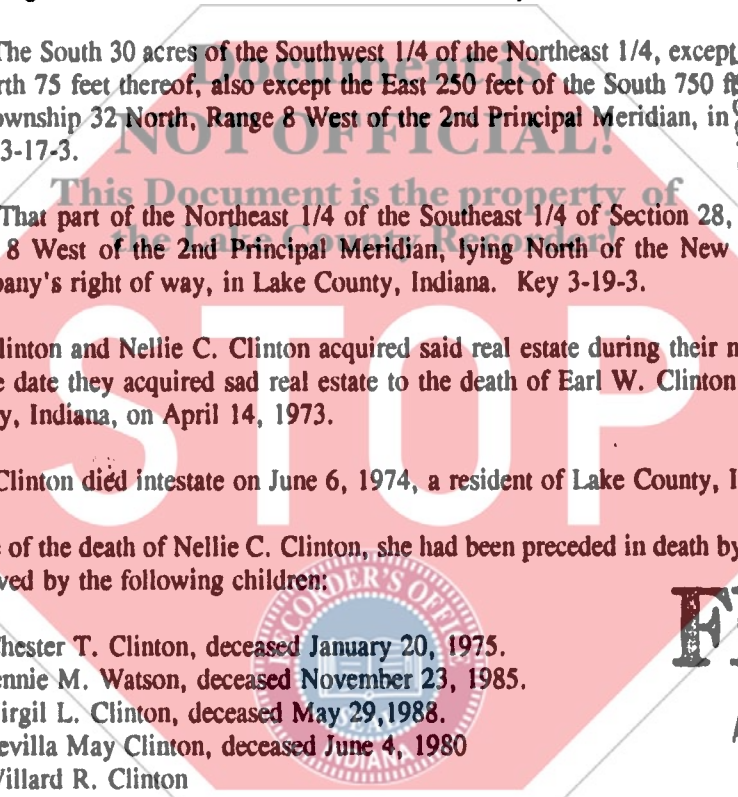
