MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE, executed by the parties hereto on the 25th day of , 1997 to evidence a certain lease of even date herewith (the "Lease").

WITNESSETH, that

- Landlord. The name of the landlord ("Landlord") is JT Holdings, Inc., its address being P.O. Box 461, Watseka, Illinois 60970.

- 3. This Memorandum of Lease (or the description of certain such rights, duties, conditions and limitations) shall in no way or under any circumstances affect the terms and conditions of the Lease or the interpretation of the rights and duties of Landlord and Tenant thereunder.
