This cause came to be heard on the 6th day of May, 1997, upon the final accounting, petition to settle and allow account, and for authority to distribute estate filed by Ronald Williams as personal representative of the estate of Ruby Johnson Williams, deceased, which account and petition are on file with the Court and a part of the Court's record.

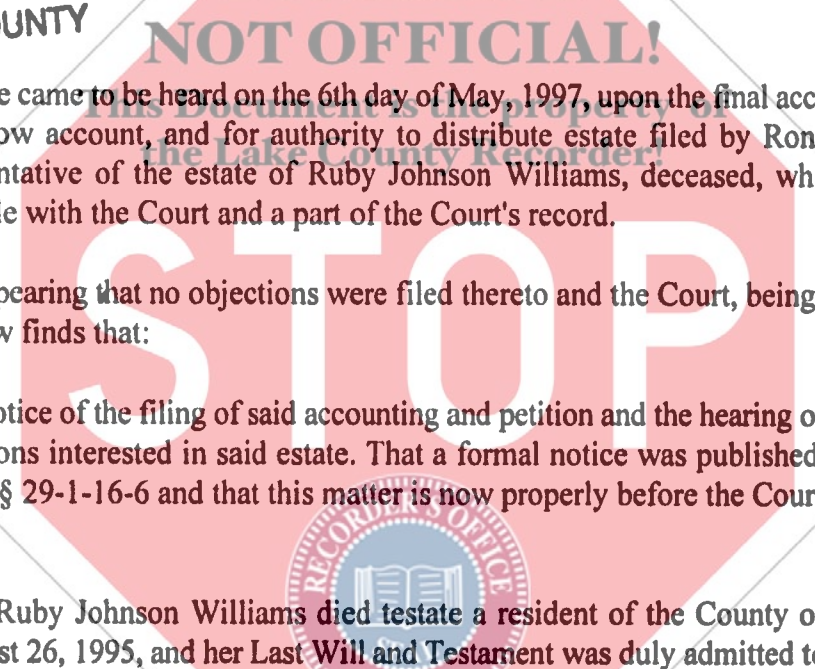
And it appearing that no objections were filed thereto and the Court, being fully advised in the premises, now finds that:

1. Due notice of the filing of said accounting and petition and the hearing on the same were given to all persons interested in said estate. That a formal notice was published pursuant to the provisions of IC § 29-1-16-6 and that this matter is now properly before the Court for final action thereon.

2. That Ruby Johnson Williams died testate a resident of the County of Lake, State of Indiana, on August 26, 1995, and her Last Will and Testament was duly admitted to probate before this Court on the 21st day of December, 1995, and this Court appointed said Ronald Williams as personal representative of the Last Will and Testament of the decedent, and said personal representative was issued Letters Testamentary on December 21, 1995, and since that date, has continued to serve in such capacity.

3. That the matters and things stated in said accounting and petition are true, and that said personal representative has accounted for all the assets in this estate coming into his hands.

4. More than five (5) months have elapsed since the date of the first published notice to legatees, devisees, and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor his personal representative were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; and all estate taxes, inheritance taxes, and gross income taxes, if any, assessed in said estate have been paid.

5. That the following persons are the sole legatees and devisees under the decedent's Last Will and Testament: Ronald Williams, 75 Wabash Terrace, San Francisco, California, 94134, Jannie Williams, 3834 Evergreen, East Chicago, Indiana, 46312, Kennie Williams, 6736 53rd Street, Sacramento, California, 95823, Laverne Perry, 1905 Northgate, Indianapolis, Indiana, 46208, James Williams, 4712 Pennsylvania Street, Gary, Indiana, 46408, Leonard Williams, 813 West Madison, Phoenix, Arizona, 85007. That all the assets and property of this estate remaining after payment of the decedent's debts and expenses of administration have been distributed to the above-named person(s), as evidenced by their receipt or voucher or said distribution should be made to the above-named parties as set forth above.

6. That the decedent owned at the time of her death a parcel of real estate located at 3832 Catalpa Street, East Chicago, Indiana, more particularly described as follows: Lot 19, Block 11, in the second addition of Indiana Harbor, in East Chicago, as shown in plat book 5, on page 18, in the office of the Lake County Recorder. 1. Said Final Report and Accounting of said personal representative is hereby in all things approved, settled, and confirmed.

2. That the distribution of the balance of the property remaining in said personal representative's hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wit: Lot 19, Block 11, in the second addition of Indiana Harbor, in East Chicago, as shown in plat book 5, on page 18, in the office of the Lake County Recorder. Commonly known as 3832 Catalpa Street, East Chicago, Indiana, Key No. 30-343-19, and that said real estate was devised to Ronald Edward Williams, pursuant to Item I of the decedent's Last Will and Testament, and title to said real estate now vests in said Ronald Edward Williams, pursuant to the office of the Lake County Recorder.

4. Said personal representative having made distribution, of all assets and property and having attached receipts or vouchers evidencing said distribution to said legatees and devisees, said distribution is hereby approved and confirmed.

5. Said personal representative has complied with the terms of this Order and is hereby released and discharged from any further liability or responsibility, along with his surety, as personal representative of the estate of Ruby Johnson Williams.
