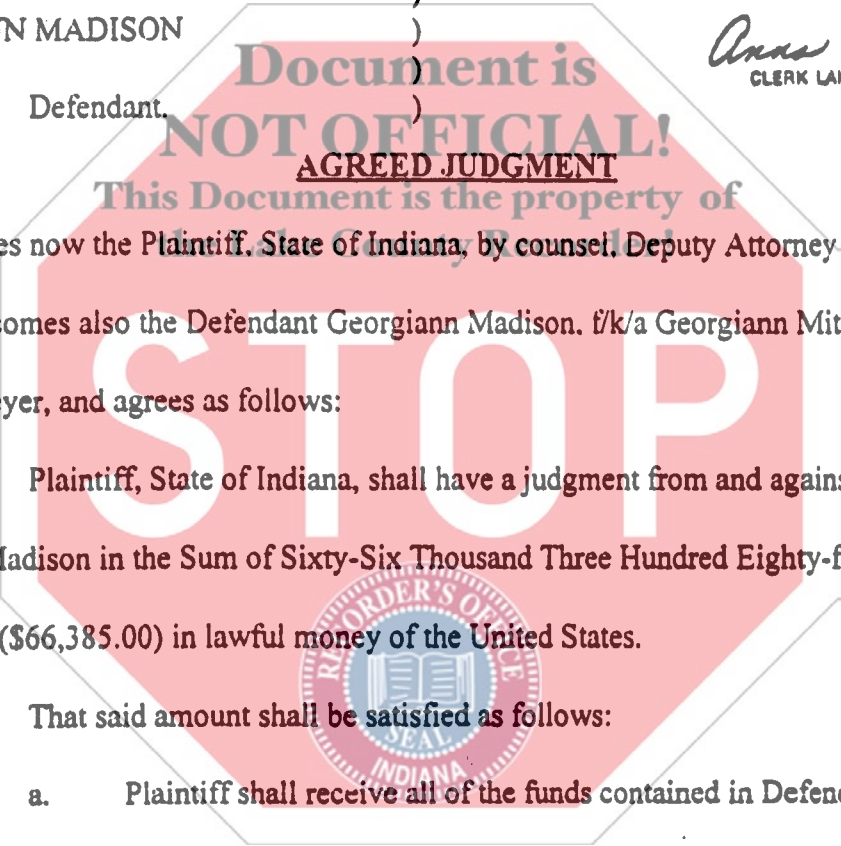

Comes now the Plaintiff, State of Indiana, by counsel, Deputy Attorney General Michael J. Case and comes also the Defendant Georgiann Madison, f/k/a Georgiann Mitchell by counsel, James B. Meyer, and agrees as follows:

1. Plaintiff, State of Indiana, shall have a judgment from and against Defendant Georgiann Madison in the Sum of Sixty-Six Thousand Three Hundred Eighty-five Dollars and 00/00 Cents (\$66,385.00) in lawful money of the United States.
2. That said amount shall be satisfied as follows:
  - a. Plaintiff shall receive all of the funds contained in Defendant Georgiann Madison's Indiana Deferred Compensation Account No. 316-72-8299, minus Defendant's 20% tax withholding.
  - b. The balance of Defendant Georgiann Madison's Indiana Deferred Compensation Account No. 316-72-8299 is Forty-eight Thousand Three Hundred Eighty-five Dollars and no/00 Cents (\$48,385.00).

Defendant Georgiann Madison hereby directs and authorizes Indiana Deferred Compensation Plan, Inc., located at 150 West Market Street, Indianapolis, Indiana, to surrender, release, and remit all of the funds contained in said Indiana Deferred Compensation Account No. 316-72-8299, minus Defendant's 20% tax withholding.

d. Defendant shall receive credit against said judgment amount for the 20% tax withholding.

e. Plaintiff shall have a valid lien, in the amount of Eighteen Thousand Dollars and no/00 Cents (\$18,000.00), against Defendant's real property located at 6788 Jefferson Street, Merrillville, Indiana, legally described as follows, to-wit:

Part of the East 1/2 of the Southeast 1/4 of Section 9, Township 35 North, Range 8 West of the 2nd Principal Meridian, in the Town of Merrillville, Lake County, Indiana, described as follows: Beginning at a point 975 feet West and 370 feet North of the Southeast corner of said section; thence North, parallel to the East line of said section, 80 feet; thence West 145 feet; thence South, parallel to the East line of said section, 80 feet; thence East 145 feet to the point of beginning.

3. That Defendant Georgiann Madison may relieve her liability under said valid lien by making payment in full of the Eighteen Thousand Dollars and no/00 Cents (\$18,000.00) at any time including, but not limited to, proceeds from the sale of the real estate described herein.
