Comes now Plaintiff, State of Indiana, by Jeffrey A. Modisett, Attorney General of
Indiana, and Jeffrey L. Simnick, Deputy Attorney General, and Defendant, Vincent J. Kirrin, by
counsel, James A. Holcomb of Lucas, Holcomb & Medrea, and file Agreed Petition to Amend
Complaint for Appropriation of Real Estate and Agreed Finding and Judgment in this cause.

THE COURT NOW FINDS that the request for the amendment of the Complaint For
Appropriation of Real Estate and Agreed Finding and Judgment should be granted based on the
agreed request and stipulation of the State of Indiana and Vincent J. Kirrin because the building
specified in the temporary right-of-way has been removed.

Lots 7, 8, 9, and 10 (excepting the East 10.00 feet) in Block 1, and the North Half of vacated 60th Street adjacent to the south line of said Lot 10 (excepting the East 10.00 feet); all in the First Addition to Gary Annex, an addition to the City of Gary, Indiana, the plat of which addition is recorded in Plat Book 9, page 34, in the Office of the Recorder of Lake County, Indiana. Containing 15,030 square feet, more or less.

IT IS FURTHER ORDERED that any temporary right-of-way of the State of Indiana over Lots 7, 8, 9, and 10 (excepting the East 10.00 feet) in Block 1, and the North half of the vacated 60th Street adjacent to the south line of said Lot 10 (excepting the East 10.00 feet); all in the First Addition to Gary Annex, an addition to the City of Gary, Indiana, the plat of which addition is recorded in Plat Book 9, page 34, in the Office of the Recorder of Lake County, Indiana, containing 15,030 square feet, more or less revert to the Defendant, Vincent J. Kirrin immediately and instanter.

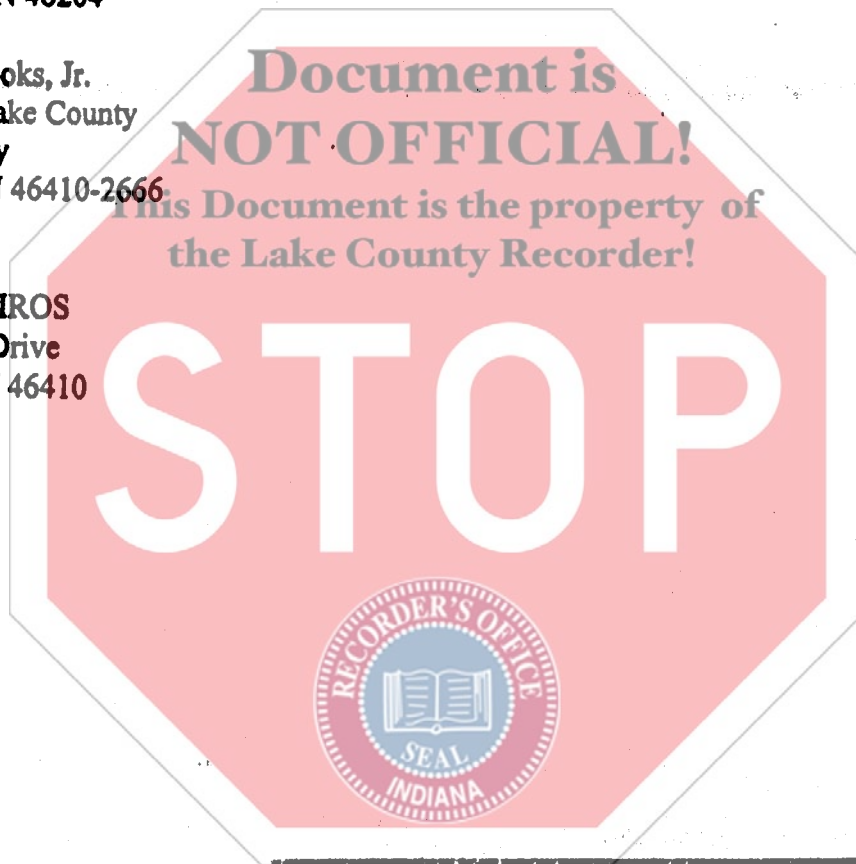
