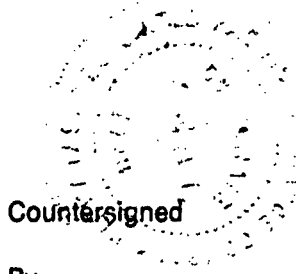
WHEREAS, Principal has applied to the Obligee for a license or permit to do business as roofing contractor
