**MEMORANDUM OF RESTATEMENT OF THE**  
**SKURKA LIVING TRUST**

1. On September 30, 1997, we fully restated our Living Trust, which was originally executed on November 22, 1993, by JOHN J. SKURKA and ELIZABETH L. SKURKA.


