# Bond Safeguard INSURANCE COMPANY

KNOW ALL MEN BY THESE PRESENTS, that BOND SAFEGUARD INSURANCE COMPANY, an Illinois Insurance Company, having its principal office in the Village of Lombard, State of Illinois, does hereby nominate, constitute and appoint William W. Hector, Eleanor Orzechowski, Denise G. Griffin, and Dennis P. Bagdon, its true and lawful Attorney(s)-In-Fact to make, execute, seal and deliver for, and on its behalf as its act and deed any and all bond and undertakings on its business of guaranteeing the fidelity of persons holding places of public or private trust and the performance of contracts other than insurance policies, and executing and guaranteeing bonds or other undertakings required or permitted in all actions or proceedings or by law required or permitted including bonds of indemnity or other obligatory instruments entered into and to bind BOND SAFEGUARD INSURANCE COMPANY thereby as fully as if such instruments had been executed by its regularly elected officers at its home office.

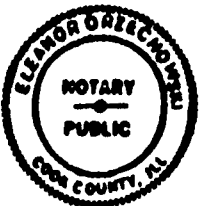
