The West half of the Northeast quarter of Section 25, Township 33 North, Range 9, West of the 2nd Principal Meridian, Lake County, Indiana, except that part appropriated in favor of the Town of Lowell and described as follows: A part of the West 1/2 of the Northeast 1/4 of Section 25, Township 33 North, Range 9 West of the 2nd P.M., described as follows: Commencing at the Northwest corner of said West 1/2 of the Northeast 1/4; thence South 0 degrees 0 minutes West along the West line of said West 1/2 of the Northeast 1/4 a distance of 2640.70 feet to the South line of said West 1/2 of the Northeast 1/4; thence South 89 degrees 6 minutes 20 seconds East along said South line a distance of 30.00 feet; thence North 0 degrees 0 minutes East parallel to said West line of the West 1/2 of the Northeast 1/4 a distance of 1017.67 feet to a point of curve; thence Northerly along a curve concave to the East that has a radius of 1436.24 feet and a tangent of 71.99 feet a distance of 143.86 feet to a point of tangent; thence North 5 degrees 44 minutes 21 seconds East a distance of 150.00 feet to a point of curve; thence Northerly along a curve concave to the West that has a radius of 1556.24 feet and a tangent of 78.01 feet a distance of 155.88 feet to a point of tangent; thence North 0 degrees 0 minutes East parallel to the West line of said West 1/2 of the Northeast 1/4 a distance of 1173.80 feet to the North line of said Section 25; thence North 88 degrees 51 minutes 30 seconds West along said North line a distance of 60.01 feet to the point of beginning, containing 2.783 acres, more or less, in Lake County, Indiana.
