**PRELIMINARY NOTICE OF DELIVERY OF MATERIAL  
AND EXISTENCE OF LIEN RIGHTS**

Lot 36, Phase Three, Whispering Woods, recorded in Plat Book 79, page 75, in the Office of the Recorder of Lake County, Indiana.


