Part of the Southwest quarter of Section 19, Township 36 North, Range 9 west of the Second Principal Meridian, in the Town of Munster, Lake County, Indiana, described as follows: beginning at a point on the West line of said Southwest Quarter, which is 281.11 feet Northerly of the Southwest corner of said Section 19, measured along said West line; thence continuing Northerly on said West line 645.90 feet to a line that is parallel to and 1,072.58 feet Southerly of the South line of Calumet View Addition to Munster, as recorded in Plat Book 18, page 25, in the Recorder's Office of Lake County, Indiana; thence Easterly on a line parallel to and 1072.58 feet Southerly of the South line of said Calumet View Addition to Munster 186.1 feet to a point that is 921.29 feet Northerly of the South line of said Section 19, measured along the line that is 186.1 feet East of the West line of said Section 19; thence Southerly on said 186.1 foot parallel line 645.35 feet; thence Westerly 186.1 feet to the place of beginning, excepting the West 40 feet taken off said tract for the opening and widening of Calumet Avenue, the South 60 feet of said tract dedicated to the Town of Munster, for a street and excepting the North 72.5 feet by parallel lines of the tract which was conveyed to the Lake County Public Library, except the south 161 feet thereof.
