**MEMORANDUM OF RESTATEMENT OF THE
PINTER LIVING TRUST**

1. On October 6, 1997, I fully restated my Living Trust, which was originally executed on November 24, 1993, by VADA B. PINTER.

2. In reliance upon the terms and conditions of my original Living Trust dated November 24, 1993, the following described real estate was transferred into the name of the Trustee of the Trust, to-wit:

Parcel I: Lots 77 and 84 in Young's Third Addition to Crown Point, as per plat thereof, recorded in Miscellaneous Record "A" pages 534 and 535, in the Office of the Recorder of Lake County, Indiana. Also, that part of the South 8 1/2 feet of Ann Street, lying North of and adjoining said Lot 77 and lying between the East and West boundary lines of said Lot 77 extended North 8 1/2 feet, which said part of Ann Street was vacated by Order of the Lake Circuit Court in Cause #17089, dated May 11, 1926, and recorded in Order Book 49 page 363, in the Office of the Clerk of said Court, Key Nos. 09-0098-0016 & 0017, 145 S. Union St., Crown Point, IN.

Parcel II: Lots 85 and 92 in Young's Third Addition to Crown Point, as per plat thereof, recorded in Miscellaneous Record "A" pages 534 and 535, in the Office of the Recorder of Lake County, Indiana, Key Nos. 09-0098-0018 & 0019, 155 S. Union St., Crown Point, IN.

3. Under the terms of the Living Trust, at the time of transfer of title to the real estate into the Trust, the Trustee and Successor Trustees designated therein, in the order in which they were to serve, were:

- B. CENTIER BANK

4. Under the terms of the Restatement of my Living Trust, now known as the Pinter Living Trust, dated October 6, 1997, the Trustee and Successor Trustees designated therein, in the order in which they are to serve, are:
