The undersigned, being first duly sworn, makes this sworn statement of intention to hold a common law lien under IC 32-8-39-1, et seq, upon the property described below and says that:

1. The undersigned JOHN A. DeMATO & ASSOCIATES, by John A. DeMato, 5625 Hohman Avenue, Hammond, Indiana 46320, intends to hold a lien on land commonly known as a single family residence located at 3915 Highway Avenue, Highland, Indiana, 46322 and legally described as follows:

Part of the following described tract: Part of the Northeast 1/4 of the Southeast 1/4 of Section 22, Township 36 North, Range 9 West of the Second Principal Meridian, in the Town of Highland, Lake County, Indiana, commencing at a point on the North line of said Northeast 1/4 of the Southeast 1/4 which is 26 2/3 rods West of the Northeast corner thereof; thence running South 80 rods, thence West 13 1/3 rods; thence North 80 rods; thence East 13 1/3 rods to the place of beginning, which part is more particularly described as follows; beginning at the Southeast corner of the aforesaid tract, thence West on the South line thereof a distance of 67.76 feet; thence North parallel to the West line of the East 1/2 of the Northeast 1/4 of the Southeast 1/4 of said sections a distance of 165 feet; said point being 67.33 feet West of the East line of the aforesaid described tract, thence East parallel to the South line of said Northeast 1/4 of the Southeast 1/4 67.33 feet to the East line of said tract, thence South along said East line 165 feet to the place of beginning.


