~~ONE HUNDRED~~ <sup>10</sup> Dollars (\$ 3,100.<sup>00</sup>) which is in payment for construction of a 42" diameter pipeline to be constructed on, over and through the presently existing 75 ft. Easement described in Right of Way Contract dated August 25, 1960, executed by Robert W. McDonald and Celesta M. McDonald, and recorded in Book 1153, Page 555 of the Lake County Indiana Recorder's Office on September 3, 1960. The easement includes a portion of the following described lands situated in Lake County, Indiana, described as follows:

Lot # Eighteen (18) in North Mill, as per plat thereof, recorded in Plat Book 49, Page 2, in the Office of the Recorder of Lake County, Indiana, and amended by Certificate of Correction recorded October 10, 1979 as Document No. 554026.

ANR Pipeline will reseed owner's lawn that is damaged during construction with the same kind of grass that existed prior to construction. Payment excludes possible damage to owner's pool & deck. Owners agree to let ANR Pipeline Company use temporary work space of 35 feet wide and 40 feet long on the West side and the East side of owner's deck during construction.

If owner's septic system is damaged as a result of the 42" Pipeline Construction, ANR Pipeline Company will repair the septic system.
