## LOAN MODIFICATION AGREEMENT

BANK CALUMET, National Association formerly known as Calumet National Bank

THE SUM of Thirty Five Thousand Dollars and 00/100s (\$35,000.00) as evidenced by a note and mortgage executed and delivered on May 8th, 1996, which said mortgage being recorded on May 13th, 1996, in Lake County, Indiana, as Document number 96031678, and

WHEREAS it is hereby agreed that for and in consideration of Ten and 00/100 Dollars (\$10.00) and other valuable considerations to the lender, the subject mortgage will be modified. After allowing for the October 18th, 1997 payment, the current principal balance will be \$30,976.55. The terms of this modification will be as follows:

- 1. The interest rate will remain fixed at 8.75%.
- 2. Beginning with the first installment due under this modification, November 1st, 1997, this loan will utilize a 15 year biweekly amortization, with a balloon payment due after 193 months. The maturity date will be March 12th, 2005.
- 3. Biweekly principal and interest payments will be \$154.80, beginning with the November 1st, 1997 payment.

ADDITIONAL payments to principal may be made at any time without penalty and interest will be charged only on the unpaid principal balance.

WHEN THE FULL AMOUNT of principal owing together with interest as above provided, shall have been paid in full, the mortgage lien shall be released. If said amount is not paid in full on or before March 12th, 2005, thence the mortgage may be foreclosed upon for any amount remaining unpaid.

NOTHING HEREIN contained shall be construed to impair the security of the said mortgage nor its successors in interest under said mortgage nor affect nor impair any right or powers which it may have under said note and mortgage for the recovery of the mortgage debt with interest at the rate above provided in case of non-fulfillment of this agreement by said mortgagor.
