We the undersigned, being duly sworn under oath state, release and covenant as follows:

1. We, Patricia K. Hallings, Husband and Wife, hereinafter referred to as owners, applied for and received Permit Number 97-454 from the Lake County Plan Commission.

2. Permit Number 97-454 was issued to owners for the construction of: RESIDENCE PATIO and 3-CAR GARAGE on property commonly known as:

13081 MONROE PLACE, CROWN POINT, IN 46307
Lake County, Indiana, whose legal description is as follows: (If parcel is not located in a subdivision, legal description is attached.)

WINGATE / LOT: 8 / CENTER TOWNSHIP

3. We are the owners of the aforementioned real property described in paragraph (2) above.
4. Several of the improvements on the subject real property were completed by the owners or their agents prior to inspection by the Lake County Building Department.

5. The nature of the improvements completed by owners and their agents now prohibits personnel from the Lake County Building Department from inspecting the improvements and determining whether the improvements were constructed in accordance with applicable regulations.

6. The improvements that were completed by owners or their agents and that cannot now inspected are as follows:

**plastic is stapled to all exterior walls, main level & upper level
insulation blown in between plastic & walls.**

7. For and in consideration of the Lake County Building Department not requiring that the owners dig up the improvements so that the construction can be inspected as required by the applicable regulations and ordinances, the owners, their transferees, assignees, successors in interest, and anyone taking title by and through owners hereby and presently releases the Lake County Plan Commission, the Lake County Building Department, and any Lake County, Indiana appointed or elected official, department or division, as well as their employees or agents from any liability directly or indirectly related to any defects in the improvements listed in paragraph 6-(a), 6-(c), and 6-(d) above that would have ascertained by inspection of these improvements at the time specified in the Lake County Building Code in force at the time this permit was issued and the improvements constructed.

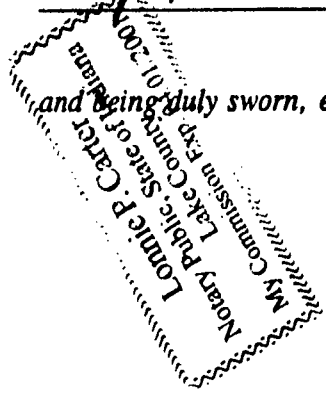
