This Will Confirm That

1. On the 5th day of August, 1997, a Revocable Trust, hereafter called "Trust", was created by John Wayne Gorman, hereafter called "Settlor", of 8545 Forest Avenue, Munster, Indiana 46321, to be known as the:

JOHN WAYNE GORMAN REVOCABLE TRUST;

2. John Wayne Gorman is therein designated as Settlor and as the initial Trustee;

- e) The name of any successor trustee may be substituted in place of the name of John Wayne Gorman, as and when such person shall succeed as the trustee herein.

8. Any property placed in the Trust shall be held and disposed of by the Trustee pursuant to the terms and conditions set forth in said Trust.

In Confirmation, the named Settlor executes this Memorandum of Trust on the 29th day of October, 1997, at Munster, Indiana.
