LICENSE BOND

KNOW ALL MEN BY THESE PRESENTS:

That we, G & H Development Corporation, ETAL, 333 W. The term of this bond is for a period commencing November 25, 1997 and terminating November 25, 1998 and may be continued from year to year by continuation certificate executed by said Surety.
