PRIVATE LIEN DECLARATION AND CLAIM OF EXEMPTION

BE IT SO DECLARED THAT:

I, WM OSTER, hold these truths to be self-evident that all men are created equal, that I am endowed by my Creator alone, above all device of government, with certain unalienable Rights, that among these are "Life, Liberty, and the Pursuit of Happiness".

In the past, you have forced me by fraud and subterfuge, indirectly, into foreign contracts by applications, and have led me to mistakenly believe that these were necessary elements in the exercise of my God given and secured rights. You have created Mala Prohibita crimes under foreign pactum, then coerced me by fraud, subterfuge and/ or coercion to sign instruments containing perjury statements under this pactum, against my knowing consent and ability, and have forced and/ or threatened jail and or fines as a condition to obey your fraudulent activities.

Therefore; let it be duly and publicly Noticed that the herein described private property shall from this day display a sovereign Flag by the Common Law and be recognized by its markings; "Sovereign, Private Property, Non-Commercial, American, Immunity Declared at Law"; colors being of Red, White, Blue and Gray, and re-numbered as evidenced upon black on white tag, and;

That this Declaration will be published as Public Notice supported by affidavit.

Under said Notice, Coloring Agreement, Affidavit, Publication and/or this Declaration, any trespass, encroachment or by any other action taken against this Flag, the herein described private property or its possessor, whether by any agency or petty bureaucrat, will subject said employee(s) or agency to immediate penalty and expense of either Civil Action, In Law, or Commercial Lien and/or possible criminal complaint.
