ORDINANCE NO. 8027

AN ORDINANCE VACATING AN ALLEY
WITHIN THE CITY OF HAMMOND, LAKE COUNTY, INDIANA

WHEREAS, Mark Dahlkamp is a freeholder of Hammond, Lake County, Indiana, and has filed a petition requesting the vacation of a portion of an alley located within the City of Hammond, Lake County, legally described as:

Commencing at the Northeast corner of Lot 3, Drackert's Second Addition, as shown in Plat Book 3, page 79, in the Recorder's Office of Lake County, Indiana; thence Southeasterly along the established South right of way line of Sibley Street, 28.17 feet; thence Southwesterly at right angles to the South line of Sibley Street to a point on the East line of Lot 5 of said Drackert's Second Addition; thence running North along the East line of Lots 5, 4 and 3 of said Drackert's Second Addition to the point of commencement, excepting therefrom that portion lying within Lot 19 of Drackert's Second Addition, as shown in Plat Book 2, page 77, in the Recorder's Office of Lake County, Indiana.

WHEREAS, the Common Council of the City of Hammond, Indiana, upon investigation and hearing in accordance with the law finds and determines that the proposed vacation would not hinder the growth or orderly development of the City of Hammond or the neighborhood in which it is located or to which it is contiguous; and

The vacation will not make access to the lands of any persons difficult or inconvenient; and

The vacation will not hinder the public's access to a church, school, or other public building or place; and


The vacation will not hinder the use of a public way by the neighborhood in which it is located or to which it is contiguous.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF HAMMOND, LAKE COUNTY, INDIANA THAT it is desired and deemed necessary to vacate the following described portion of the alley described as follows, to-wit:

Commencing at the Northeast corner of Lot 3, Drackert's Second Addition, as shown in Plat Book 3, page 79, in the Recorder's Office of Lake County, Indiana; thence Southeasterly along the established South right of way line of Sibley Street, 28.17 feet; thence Southwesterly at right angles to the South line of Sibley Street to a point on the East line of Lot 5 of said Drackert's Second Addition; thence running North along the East line of Lots 5, 4 and 3 of said Drackert's Second Addition to the point of commencement, excepting therefrom that portion lying within Lot 19 of Drackert's Second Addition, as shown in Plat Book 2, page 77, in the Recorder's Office of Lake County, Indiana.


The Clerk shall furnish a copy of this Ordinance to the County Recorder for recording and to the County Auditor.

This Ordinance shall be in full force and effect from and after the passage and approval by the Mayor.






