All that part of Lot No. 6, as marked and laid down on the recorded plat of Moore's Addition to the Town of Lovell, Lake County, Indiana, as the same appears of record in Miscellaneous Record "A", page 507, in the Recorder's Office of Lake County, Indiana, commencing 6 rods East from the Southwest corner of said Lot; thnce North parallel to the West line of said lot to a point in the North line of said lot, (which line is also designated and identified as high water mark in the Mill Pond), thence Easterly along the Northerly line of said lot to a division fence of said Lot about 6 rods more or less to the Northwest corner of that part of said lot deeded by Horace Gragg and wife Ruth, to R. W. Price, recorded January 22, 1867 in Deed Record 8, page 503; thence South along the West line of said Price tract to the South line of said lot; thence West to the plat of beginning, except that part of said lot beginning at a point on the Southeast corner of the property now owned by the Northern Indiana Public Service Company, said point being 99 feet East of the West line of said Lot 6, said point also being 169.5 feet North of the South line of said Lot 6; thence East parallel to the South line of said Lot 6, a distance of 25 feet to a point; thence North parallel to the West line of said Lot 6, a distance of 171 feet more or less to the North line of said Lot on the high water mark of the Mill Pond; thence Southwesterly along the high water mark of the Mill Pond, a distance of 37 feet more or less to a point on the Northeast corner of the property now owned by the Northern Indiana Public Service Company, said point being 99 feet East of the West line of said Lot 6, said point also being 314.89 feet North of the South line of said Lot 6, thence South a distance of 145.39 feet to the point of beginning, and further excepting that part of said lot beginning at a point 169.5 feet North and 99 feet East of the Southwest corner of Lot 6, thence East 26 feet thence South parallel with the West line of Lot 6, a distance of 75 feet; thence West 26 feet; thence North parallel with the West line of Lot 6, a distance of 75 feet to the point of beginning.
