THE SUM of Sixty Thousand Dollars and 00/100s (\$60,000.00) as evidenced by a note and mortgage executed and delivered on December 16th, 1994, which said mortgage being recorded on December 22nd, 1994, in Lake County, Indiana, as Document number 94086018 and,

WHEREAS it is hereby agreed that for and in consideration of Ten and 00/100 Dollars (\$10.00) and other valuable considerations to the lender, the subject mortgage will be modified. The current principal balance will be \$56,226.19. The loan balance was increased \$2,517.16 to pay the modification recording fee of \$12.00, October 1st, 1997 payment of \$665.70, November 1st, 1997 payment of \$665.70 and escrow payment of \$1,173.76. The 2,517.16 advance will be amortized over the remaining term of the loan. The terms of this modification will be as follows:

- 1. The rate of interest will remain fixed at 8.625%.
- 2. Beginning with the first installment due under this Modification, December 1st, 1997, this loan will utilize a 146 month amortization. The maturity date will be January 1st, 2010.
- 3. Monthly principal and interest payments will be \$623.15. The total monthly payment, including escrows, will be \$693.60, beginning with the December 1st, 1997 payment.

ADDITIONAL payments to principal may be made at any time without penalty and interest will be charged only on the unpaid principal balance.

WHEN THE FULL AMOUNT of principal owing together with interest as above provided, shall have been paid in full, the mortgage lien shall be released. If said amount is not paid in full on or before January 1st, 2010, thence the mortgage may be foreclosed upon for any amount remaining unpaid.

NOTHING HEREIN contained shall be construed to impair the security of the said mortgage nor its successors in interest under said mortgage nor affect nor impair any right or powers which it may have under said note and mortgage for the recovery of the mortgage debt with interest at the rate above provided in case of non-fulfillment of this agreement by said mortgagor.
