- 2. **EFFECTIVE DATE OF POWER OF ATTORNEY**: This power of attorney shall become effective on the date this Durable General Power of Attorney is executed by GEORGIA LOUISE ALLEN a/k/a LOUISE M. ALLEN.
- 3. **POWERS**: I give to my attorney-in-fact or any successor attorneys-in-fact, the powers incorporated by reference in this section which include those powers set forth in I.C. 30-5-5-2 through I.C. 30-5-5-15 and 30-5-5-18 and 30-5-5-19 (expressly excluding health care powers and power to consent to or refuse health care which powers I specifically confer through separate instrument) as they exist now and as they may be hereafter amended, from time to time, to be used on my behalf:
 - 3.01 REAL PROPERTY TRANSACTIONS: General authority with respect to real property transactions pursuant to I.C. 30-5-5-2, and specifically including the power to exercise all statutory powers and to act on my behalf in all respects in connection with the real estate and improvements I own at 9 Deer Path Road, Merrillville, Indiana.
 - 3.02 TANGIBLE PERSONAL PROPERTY TRANSACTIONS: General authority with respect to tangible personal property transactions pursuant to I.C. 30-5-5-3.
 - 3.03 BOND, SHARE AND COMMODITY TRANSACTIONS: General authority with respect to bond, share and commodity transactions pursuant to I.C. 30-5-5-4.
 - 3.04 BANKING TRANSACTIONS: General authority with respect to banking transactions, pursuant to i.C. 30-5-5-5, and specifically including the power to act on my behalf in all respects in connection with any safety deposit box in which I may have an interest.
 - 3.05 **BUSINESS OPERATING TRANSACTIONS**: General authority with respect to business operating transactions pursuant to 1.C. 30-5-5-6.
 - 3.06 INSURANCE TRANSACTIONS: General authority with respect to insurance transactions pursuant to I.C. 30-5-5-7; provided, however, the references in I.C. 30-5-5-7(a)(2) and (3) to "... section 8 of this chapter" shall be deemed references instead to I.C. 30-5-5-9.

- 3.08 **GIFT TRANSACTIONS**: General authority with respect to gift transactions pursuant to I.C. 30-5-5-9.
- 3.09 **FIDUCIARY TRANSACTIONS**: General authority with respect to fiduciary transactions pursuant to I.C. 30–5–5–10.

- 3.13 **RECORDS, REPORTS AND STATEMENTS**: General authority with respect to records, reports and statements pursuant to I.C. 30–5–5–14 including the power to execute on my behalf any specific power of attorney required by any taxing authority to allow my attorney-in-fact to act on my behalf before that taxing authority on any return or issue.
- 3.14 **ESTATE TRANSACTIONS**: General authority with respect to estate transactions pursuant to I.C. 30–5–5–15.
- 3.15 **DELEGATION OF AUTHORITY**: General authority with respect to delegating authority pursuant to 1.C. 30-5-5-18.
- 3.16 ALL OTHER MATTERS: General authority with respect to all other matters pursuant to I.C. 30-5-5-19.
- 4. SUPERSEDES PRIOR POWERS OF ATTORNEY: This power of attorney supersedes, and I hereby revoke, all other powers of attorney I may have executed prior to the date of this power of attorney.
- 5. **GUARDIAN**: In the event protective proceedings for my person or estate are commenced, or a guardian is requested to act on my behalf, I nominate my attorney-in-fact to act on my behalf pursuant to I.C. 30-5-3-4(a).
- 6. **INCAPACITY**: This power of attorney shall not terminate upon my becoming incapacitated.
- 7. **TERMINATION ON DEATH**: This power of attorney shall terminate upon my death except as otherwise provided by I.C. 30–5–10–4.
- 8. **REVOCATION**: This power of attorney may be revoked, only by my written revocation entered of record in the office of the County Recorder of Lake County, Indiana. Any such revocation must be signed and acknowledged before a Notary Public or other similar official authorized to administer oaths.

9. COPIES: This instrument may be filed of record in any one or more counties within and without the State of Indiana or elsewhere as may be deemed appropriate by my Attorney, and copies of this instrument, certified as true or exact copies by the County Recorder of any of said counties, shall be treated as original copies for all purposes.
