

A parcel of land in the Northeast 1/4 of the Southeast 1/4 of Section 15, Township 36 North, Range 7 West of the Second Principal Meridian in Porter County, Indiana as shown by the unrecorded plat of said Victor Brandt's First Addition to Garyton being more particularly described by metes and bounds as follows to wit: Commencing at a point 920 feet West of the East line of said Section 15 in Township and Range aforesaid and 521.65 feet North of the South line of said Northeast 1/4 of the Southeast 1/4 of said Section 15 (the East side of said Northeast 1/4 of Southeast 1/4 being 1324.16 feet) and running thence West from said point of beginning 260 feet along a line parallel to the South line of said Northeast 1/4 of the Southeast 1/4 of said Section 15, thence South parallel to the East line of said Section 15, 66 feet; thence East parallel to the South line of said Northeast 1/4 of the Southeast 1/4 of said Section 15, 260 feet; thence North parallel to the East line of said Section 15, 66 feet to the point of beginning EXCEPTING therefrom beginning at a point 920 feet West and 455.16 feet North of the Southeast corner of the Northeast 1/4 of Southeast 1/4 of said Section 15, and running thence West 130 feet; thence North 66 feet; thence East 130 feet; thence South 66 feet to the point of beginning also known as Lots 22 and 23 in Block 7 in Victor Brandt's First Addition to Garyton.
