## **MODIFICATION AND EXTENSION AGREEMENT**

AGREEMENT made this 15th day of November, A.D. 1997 between Peotone Bank and Trust Company, a banking corporation, organized and existing under the laws of the State of Illinois, party of the first part and Theodore M. Yakima, a married man, of the Township of Green Garden, County of Will and State of Illinois, party of the second part witnesseth:

- 2. Interest, currently 10.75%, at a variable rate of Peotone Bank & Trust Co. base lending rate plus 1.00%, shall be payable on said note on the 15th day of May and November, beginning May 15, 1998.
- 3. That the aforesaid payments and interest shall be secured by the mortgage recorded as Document No. 96080450 in the same manner as if the changes herein had been specifically described therein and that the mortgage and all the provisions, stipulations, powers, terms and covenants therein shall be in full force and effect except as hereby modified.
