the suspension or termination of the attorney-in-fact as a Seller or Servicer of mortgages to FHLMC,

(ii)

the transfer of servicing from the attorney-in-fact to another Servicer for cause,

(iii)

the appointment of a receiver or conservator with respect to the business of the attorney-in-fact, or



the filing of a voluntary or involuntary petition in bankruptcy by the attorney-in-fact or any of its creditors.

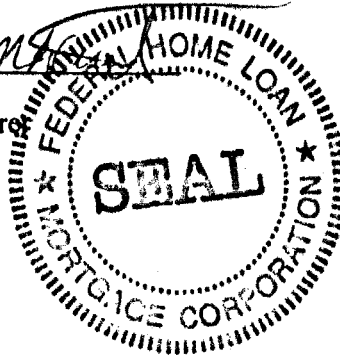



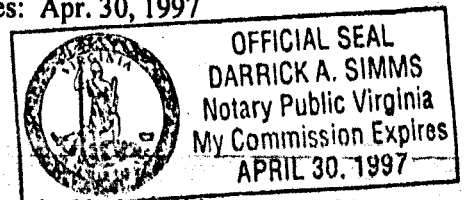
