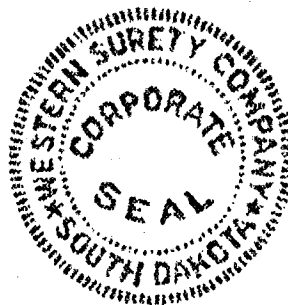

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

as Attorney-in-Fact, with full power and authority hereby conferred upon him to sign, execute, acknowledge and deliver for and on behalf of Western Surety Company and as its act and deed, all of the following classes of documents to-wit:

The corporate seal is not necessary for the validity of any bonds, policies, undertakings, Powers of Attorney or other obligations of the corporation. 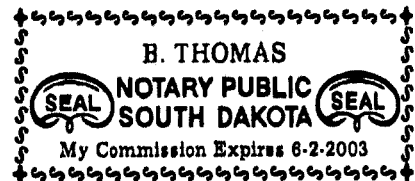
