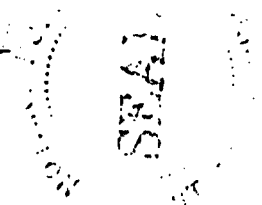

LEGAL DESCRIPTION

PART OF THE NORTHWEST QUARTER OF SECTION 33, TOWNSHIP 36 NORTH, RANGE 9 WEST OF THE SECOND PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS: COMMENCING AT A POINT 50 FEET EAST OF THE WEST LINE OF SAID SECTION 33 AND 909.05 FEET SOUTH OF THE NORTH LINE OF THE SAID SECTION, THENCE SOUTH 89 DEGREES 44 MINUTES 28 SECONDS EAST A DISTANCE OF 380 FEET TO THE POINT OF BEGINNING; THENCE SOUTH 213.34 FEET, MORE OR LESS TO THE NORTHWEST CORNER OF LOT 1, FIELDHOUSE ADDITION TO THE TOWN OF HIGHLAND, AS SHOWN IN PLAT BOOK 56, PAGE 26; THENCE EAST 214.38 FEET ALONG SAID FIELDHOUSE ADDITION TO THE NORTHEAST CORNER THEREOF; THENCE NORTH 228.06 FEET, MORE OR LESS, TO THE CENTER LINE OF THE TEXACO-CITIES SERVICE PIPELINE EASEMENT AS SHOWN ON THE PLAT OF FIELDHOUSE ADDITION; THENCE SOUTH 65 DEGREES 18 MINUTES WEST A DISTANCE OF 36.21 FEET; THENCE NORTH 89 DEGREES 44 MINUTES 28 SECONDS WEST A DISTANCE OF 181.48 FEET TO THE POINT OF BEGINNING, IN THE TOWN OF HIGHLAND, IN LAKE COUNTY, INDIANA.
