I reserve unto myself, however, the power to act on my own behalf and also to revoke or amend this Power of Attorney as permitted by I.C. 30-5-10-1, I, as principal, specifically provide that my attorney in fact is liable only if my attorney in fact acts in bad faith pursuant to I.C. 30-5-9-5. This Power of Attorney terminates upon completion of the purpose set out herein.
