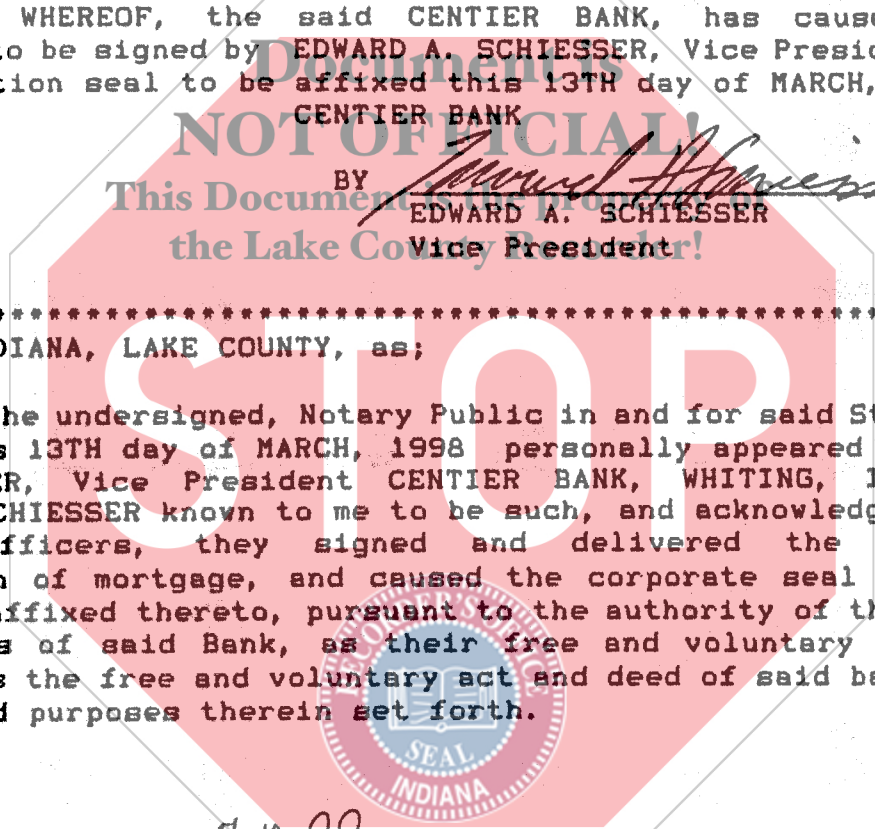

EXHIBIT I

A parcel of land located in the Northeast Quarter of Section 8, Township 35 North, Range 8 West of the 2nd Principal Meridian, in Lake County, Indiana, being more particularly described as follows: Beginning at a point in the center line of the Crown Point and Lottaville Road 777.88 feet Northeasterly from the intersection of said center line and the Northeasterly line of the right of way of the Grand Trunk Railway, thence South 37 degrees 43 minutes East at right angles to said road 580.8 feet, thence North 52 degrees 17 minutes East a distance of 75 feet, thence North 37 degrees 43 minutes West at right angles to said road 580.8 feet to the center line of said road, thence Southwesterly along the center line of said road, 75 feet to the place of beginning.
