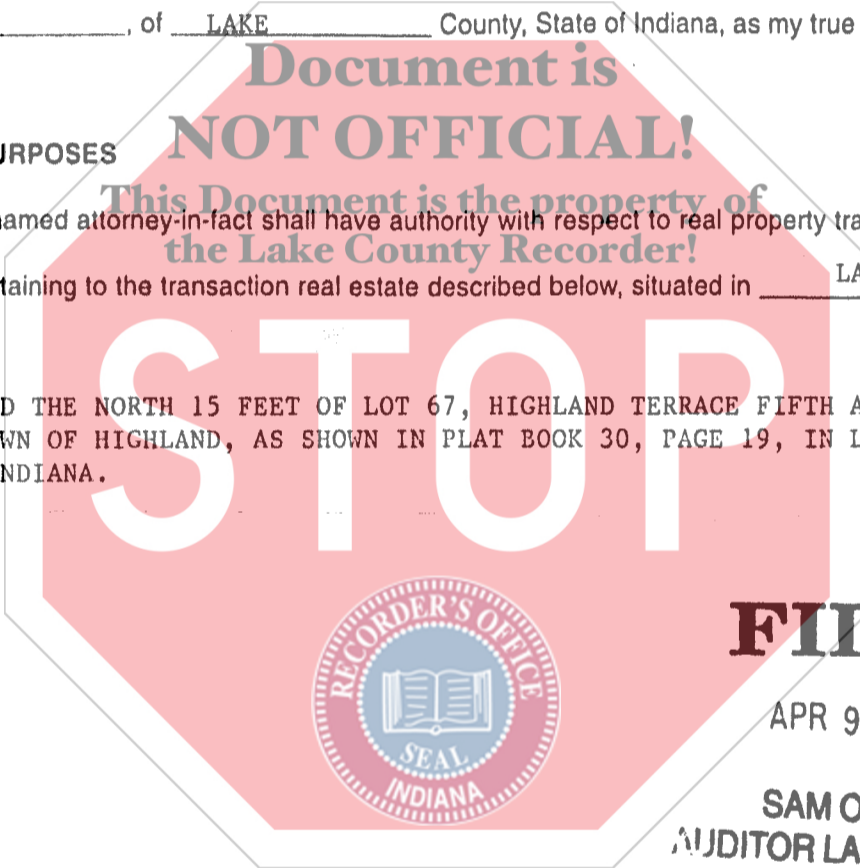
I/We, JOHN BUKSAR, of LAKE County, State

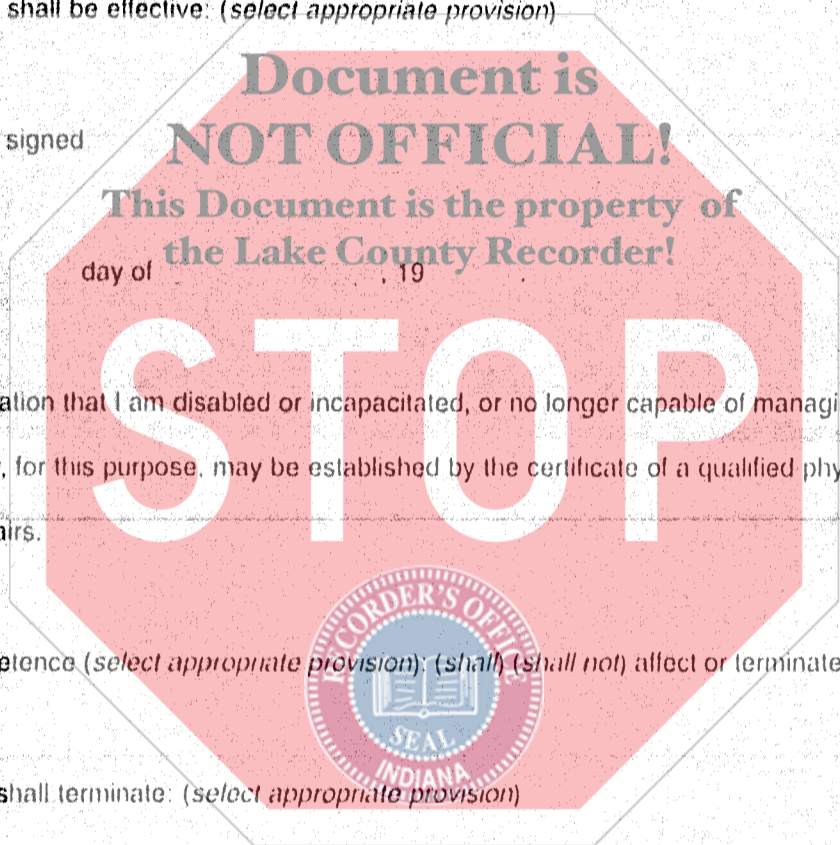
