PARTIAL RELEASE OF MORTGAGE



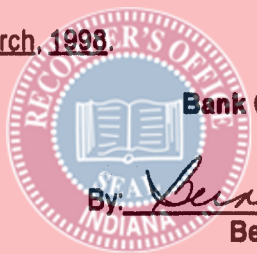

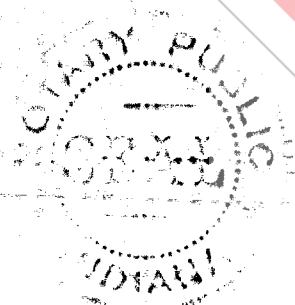
