

LEGAL DESCRIPTION

PARCEL I: Lots 1-20, both inclusive, and the Westerly 35 feet of Lot 21 in Kennedy Park Subdivision, in the City of Hammond, as per plat thereof, recorded in Plat Book 36 page 21, in the Office of the Recorder of Lake County, Indiana.

PARCEL II: Lots 23 to 27, both inclusive, in Kennedy Park Subdivision Second Addition, in the City of Hammond, as per plat thereof, recorded in Plat Book 37 page 22, in the Office of the Recorder of Lake County, Indiana.

PARCEL III: Easement for vehicular and pedestrian ingress and egress over, under and across the real estate described as follows:

Part of Lot 21 in Kennedy Park Subdivision, in the City of Hammond, as per plat thereof, recorded in Plat Book 36 page 21, in the Office of the Recorder of Lake County, Indiana, described as follows: Starting at a point on the North line of Lot 21, said point being 75 feet East of the Northwest corner of Lot 21, proceed South 30 feet; thence proceed Southwesterly 103 feet, more or less, to a point on the East line of the West 35 feet of Lot 21, said point being 125 feet South of the North line; thence proceed North 125 feet to the North line; thence proceed 40 feet East to the point of beginning, as granted by Grant of Easement dated November 15, 1976, and recorded December 10, 1976 as Document No. 383376, made by Irwin H. Cole and Shirley Cole, his wife, to Mercantile National Bank of Indiana, a National Banking Association, not personally but as Trustee under Trust Agreement dated September 20, 1976 and known as Trust No. 3509.

PARCEL IV: (1) Outlot "A", "B" and "C" in Kennedy Park Subdivision, in the City of Hammond, as per plat thereof, recorded in Plat Book 36 page 21, in the Office of the Recorder of Lake County, Indiana.

(2) Lot 22 and Lot 21, except the West 35 feet thereof, in Kennedy Park Subdivision, in the City of Hammond, as per plat thereof, recorded in Plat Book 36 page 21, in the Office of the Recorder of Lake County, Indiana.
