

of December, 1998, unless renewed by continuation certificate.


This bond may be terminated at any time by the Surety upon sending notice in writing to the Obligee and to



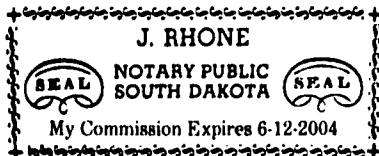


