DEED ON DECREE

This Indenture, Made this 3rd day of April, A.D. 1998 between John Buncich, Sheriff of Lake County, in the State of Indiana, of the first part and SECURITY FEDERAL BANK, a F.S.B. of the County of Lake and State of Indiana of the second part. **WITNESSETH:**

THAT WHEREAS, At the Continuous Term of the Lake Superior Court A.D., 1998, SECURITY FEDERAL BANK, a F.S.B. recovered by judgment of said Court, in a certain action therein against SEBASTIAN HEREDIA; The unknown heirs, devisees, legatees, husbands, widowers, successors, executors, administrators, personal representatives, guardians, trustees, receivers, and unknown grantees and lessees of SEBASTIAN HEREDIA, Deceased, 4220 Tod Avenue, East Chicago, IN 46312 the sum of Sixty-six Thousand Eighty-two Dollars and Forty-one Cents, for its damages, together with the further sum of No Dollars and No Cents, for its costs in that behalf expended; and a decree for the sale of all the interest, estate, right and title of the defendant, SEBASTIAN HEREDIA; etal., in and to certain Real Estate, described therein as follows, to-wit:

Lot 45, Block 5, Subdivision of the Northeast Quarter of Section 29, Township 37 North, Range 9 West of the 2nd P.M., in the City of East Chicago, as shown in Plat Book 2, Page 15, in Lake County, Indiana.

All without any relief whatever from valuation of appraisal laws, as by the record thereof remaining in said Court more fully appears.

AND WHEREAS, Afterwards, to-wit: On the 23rd day of January, A.D. 1998 a copy of said judgment and decree was duly issued, and under seal of said Court, attested by the Clerk thereof, directed to the Sheriff of the County of Lake, commanding him that after due and legal notice of the time and place of making the same, he should sell the land above described, with all the interest, estate, right and title of the defendant, SEBASTIAN HEREDIA; etal., therein, or so much and such parts thereof as might be necessary, according to the terms of said decree, to pay and satisfy the judgment aforesaid, with the interest and cost thereon; and that he should in like manner also make and return all interest and accruing costs thereon, and make due return of said writ to the Clerk's office at the expiration of one hundred and eighty days from the date of the same.

AND WHEREAS Said copy of judgment and order of sale, on the 23rd day of January, A.D. 1998, came to the hands of John Buncich then the Sheriff of said County, to be executed, and the said John Buncich as said Sheriff as aforesaid, having legally advertised the same, did on the 3rd day of April, A.D. 1998, at the Court House door in Crown Point in the County aforesaid, between the hours prescribed by law, at public auction, expose to sale the rents, profits, issues and income, of said estate of SEBASTIAN HEREDIA; etal., together with all the rights, title and interest in fee simple of the said SEBASTIAN HEREDIA; etal.; in and to said estate, and the said SECURITY FEDERAL BANK, a F.S.B. did then and there bid the sum of Sixty-six Thousand Eighty-two Dollars and Forty-one Cents, and no person bidding more, the same was in due form openly struck off and sold to the said SECURITY FEDERAL BANK,, a F.S.B. for the said sum of Sixty-six Thousand Eighty-two Dollars and Forty-one Cents its being the highest bidder, and that being the highest price bid for the same.
