


This undertaking may not be changed or modified orally. No change or modification shall be effective unless made by written endorsement issued to form a part hereof.



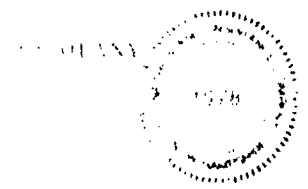
