before the Court for final action thereon.

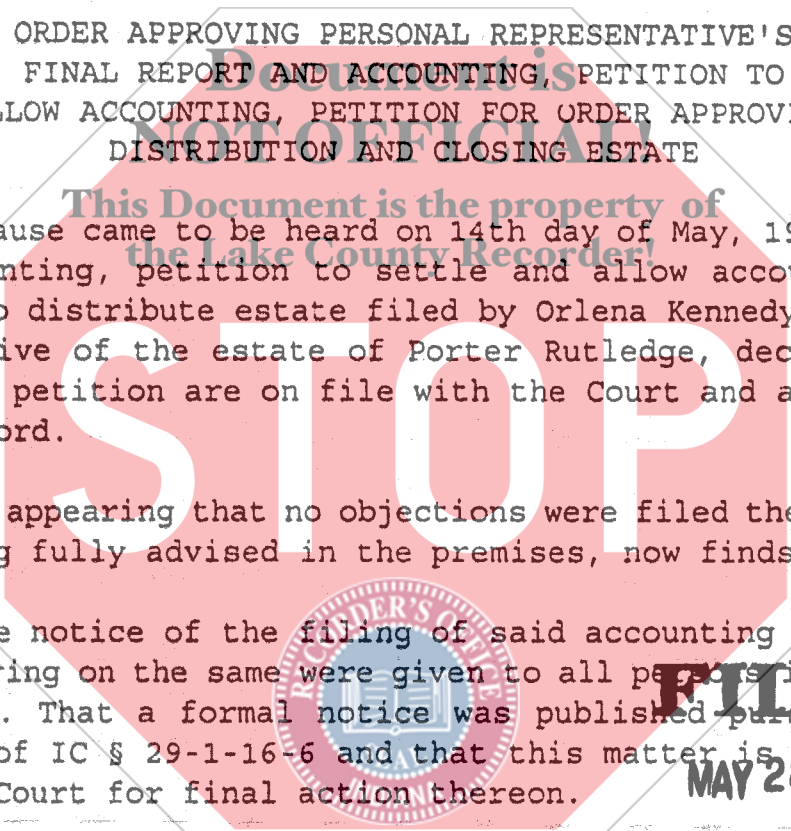
2. That Porter Rutledge died testate a resident of Lake County

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED by the Court as follows:

1. Said Final Report and Accounting of said personal representative is hereby in all things approved, settled, and confirmed.

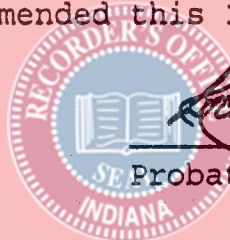

That the distribution of the balance of the property remaining in said personal representative's hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. 4. Said personal representative having made distribution of all assets and property and having attached receipts or vouchers evidencing said distribution to said legatees and devisee, said distribution is hereby approved and confirmed.

5. Said personal representative is hereby released and discharged from any further liability or responsibility, along with her surety, as personal representative of the Estate of Porter Rutledge.
