property in his own name, a fee simple interest, until the time of his death.

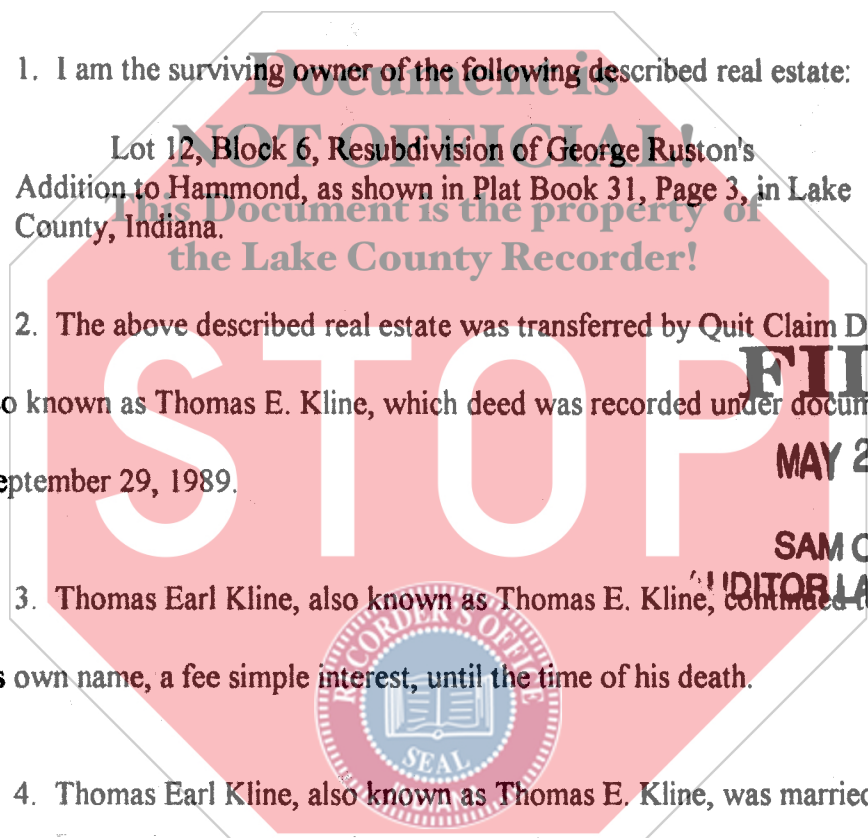
4. Thomas Earl Kline, also known as Thomas E. Kline, was married to Zorica

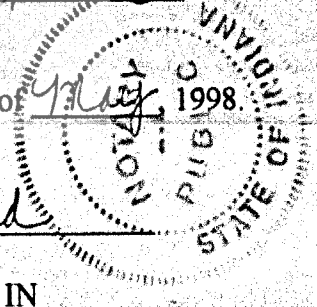
