4. That on the date of death of Patrick M. Mielcarek he was not married and had no children that were living nor was he survived by any parents.

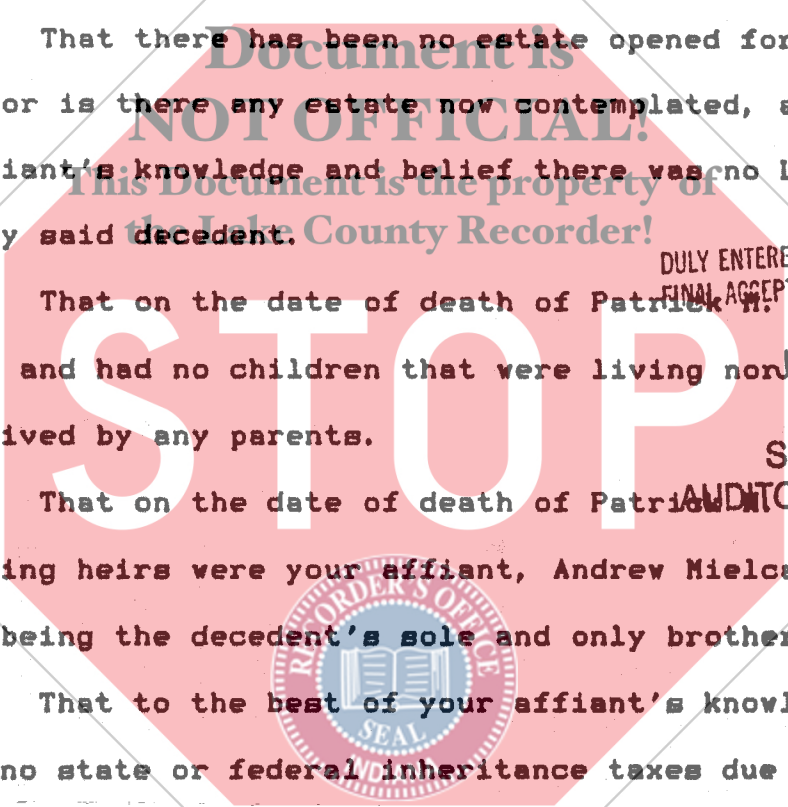

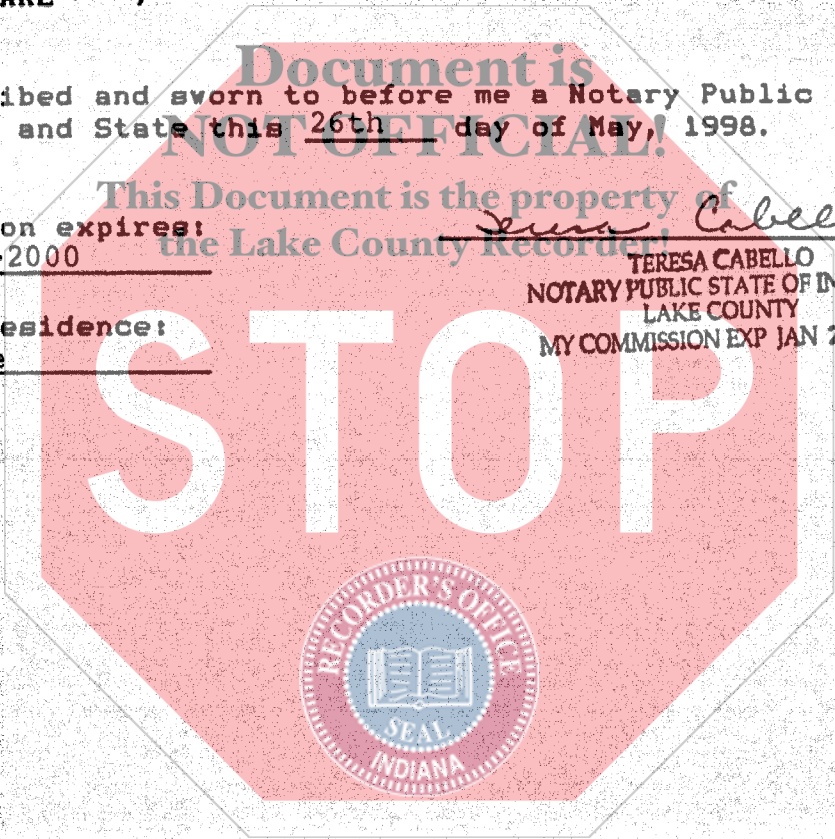
