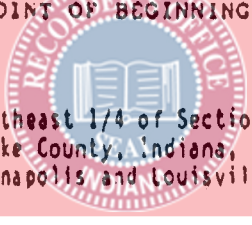
THE EAST 1/2 OF THE NORTHEAST 1/4 OF SECTION 35, TOWNSHIP 33 NORTH, RANGE 9 WEST OF THE 2ND P.M., IN LAKE COUNTY, INDIANA, LYING NORTH OF THE CENTER LINE OF THE PUBLIC HIGHWAY KNOWN AS BELSHAW ROAD, EXCEPTING THEREFROM THAT PART LYING NORTH OF THE RIGHT OF WAY OF THE CHICAGO, INDIANAPOLIS AND LOUISVILLE RAILWAY COMPANY AND ALSO EXCEPTING THEREFROM THE FOLLOWING DESCRIBED PARCELS A, B AND C:
