LEGAL DESCRIPTION

Parcel D

That portion of Lot 4 in Whispering Oaks Addition, Phase 2, as per plat thereof recorded on May 8, 1997 in Plat Book 82, Page 59, Document Number 97028942, in the Office of the Recorder of Lake County, Indiana, being more particularly described as follows: commencing at the northeast corner of said Lot 4; thence south 0°00'45" east along the east line of said Lot 4, a distance of 21.17 feet to the point of beginning; thence continuing south 0°00'15" east 139.40 feet; thence northerly and northwesterly along a curve concave to the west, having the following elements, a radius of 45.0 feet, a central angle of 13°29'06", and an arc length of 10.59 feet; thence north 53°30'00" east 19.01 feet; thence north 39°33'15" east 152.75 feet to the point of beginning.
