

FARLES' LAKE GEORGE FIFTH SUBDIVISION, AS PER PLAT THEREOF, RECORDED IN PLAT BOOK 10, PAGE 20, IN THE OFFICE OF THE RECORDER OF LAKE COUNTY, INDIANA, AS PART OF THE SOUTHEAST 1/4 OF THE NORTHEAST 1/4 OF SECTION 31, TOWNSHIP 36 NORTH, RANGE 7 WEST OF THE 2ND PRINCIPAL MERIDIAN, IN THE CITY OF HOBARTY BEING BOUND AND DESCRIBED AS FOLLOWS. ON THE WEST BY THE EAST LINE OF ASH STREET, ON THE SOUTH BY THE NORTH LINE OF THIRD STREET AS NOW LOCATED ON THE NORTH BY THE SOUTH LINE OF BURLINGTON PLACE.
