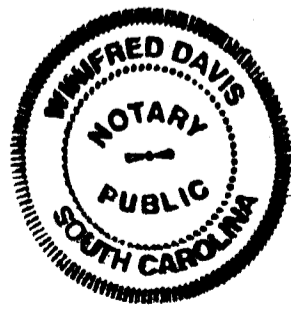

PARCEL 1: PART OF THE NORTHEAST QUARTER OF SECTION 4, TOWNSHIP 32 NORTH, RANGE 9 WEST OF THE 2ND PRINCIPAL MERIDIAN, DESCRIBED AS COMMENCING IN THE CENTER OF THE PUBLIC HIGHWAY KNOWN AS THE STATE ROAD PASSING THROUGH SAID SECTION, AT A POINT 40 FEET EAST OF THE EAST LINE OF THE RIGHT OF WAY OF THE INDIANA HARBOR RAILROAD, NOW THE CHICAGO, INDIANA AND SOUTHERN RAILROAD COMPANY; THENCE NORTH PARALLEL WITH THE EAST LINE OF THE RIGHT-OF-WAY OF SAID RAILROAD 150 FEET; THENCE EAST PARALLEL WITH THE CENTER LINE OF SAID HIGHWAY 60 FEET; THENCE SOUTH PARALLEL WITH SAID RAILROAD TO THE CENTER LINE OF SAID STATE ROAD, A DISTANCE OF 150 FEET; THENCE WEST ALONG THE CENTER LINE OF SAID HIGHWAY 60 FEET TO THE POINT OF BEGINNING, IN LAKE COUNTY, INDIANA.
