

TAX DEED

WHEREAS CARL E. FOX did the 12th day of DECEMBER, 1996 produce to the undersigned, Sam Orlich Auditor of the County of Lake in the State of Indiana, a certificate of sale dated the 5th day of OCTOBER, 1995, signed by Sam Orlich who, at the date of sale, was Auditor of the County, from which it appears that CARL E. 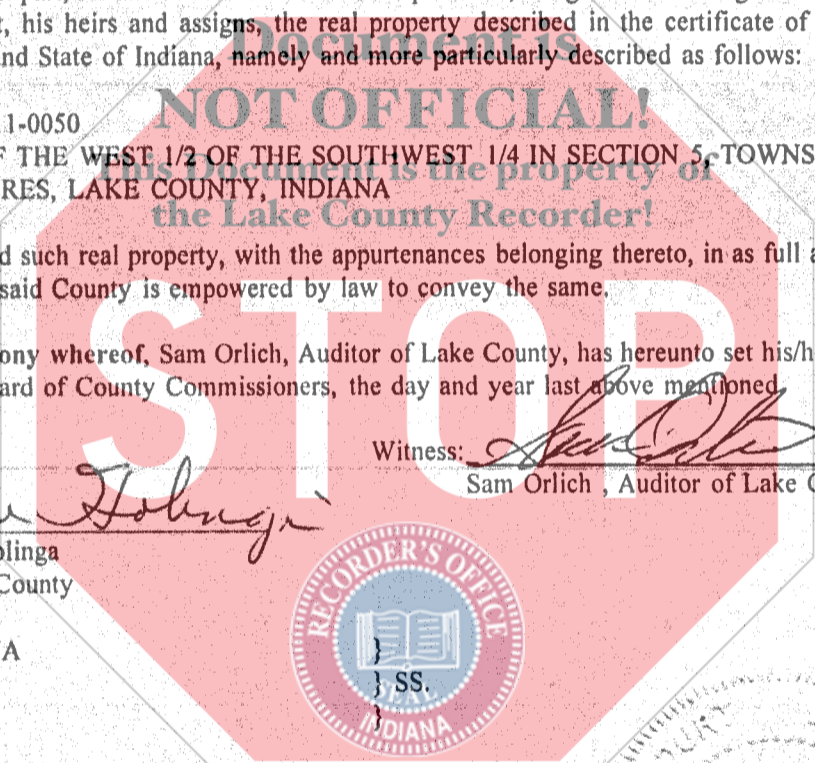
