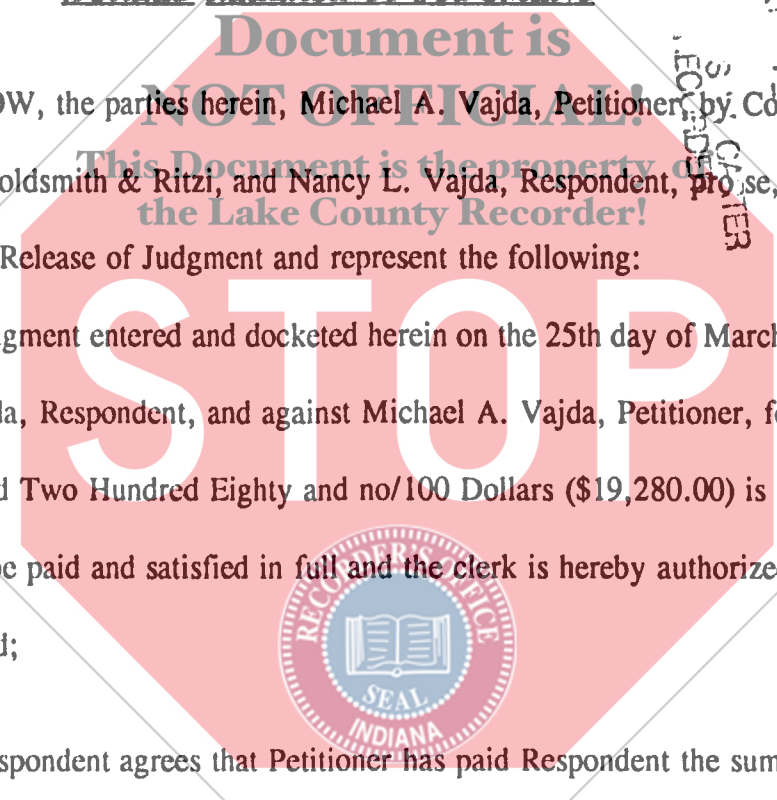
AGREED RELEASE OF JUDGMENT

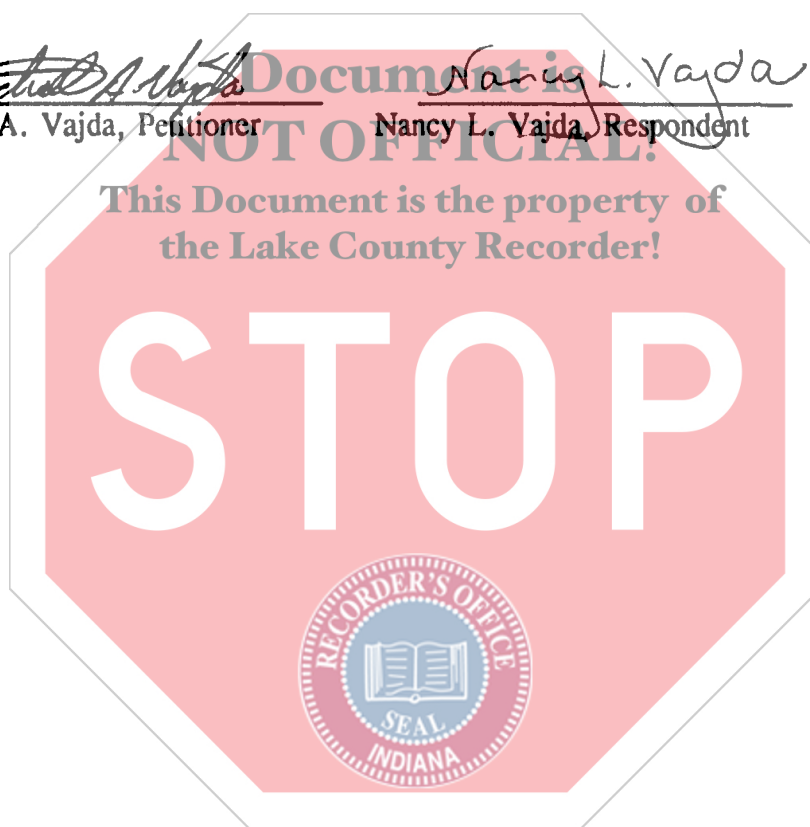
