2. Permit Number 96-174 was issued to owners for the construction of: 9549 W. 159th Ave. Lowell, In. on property commonly known as:

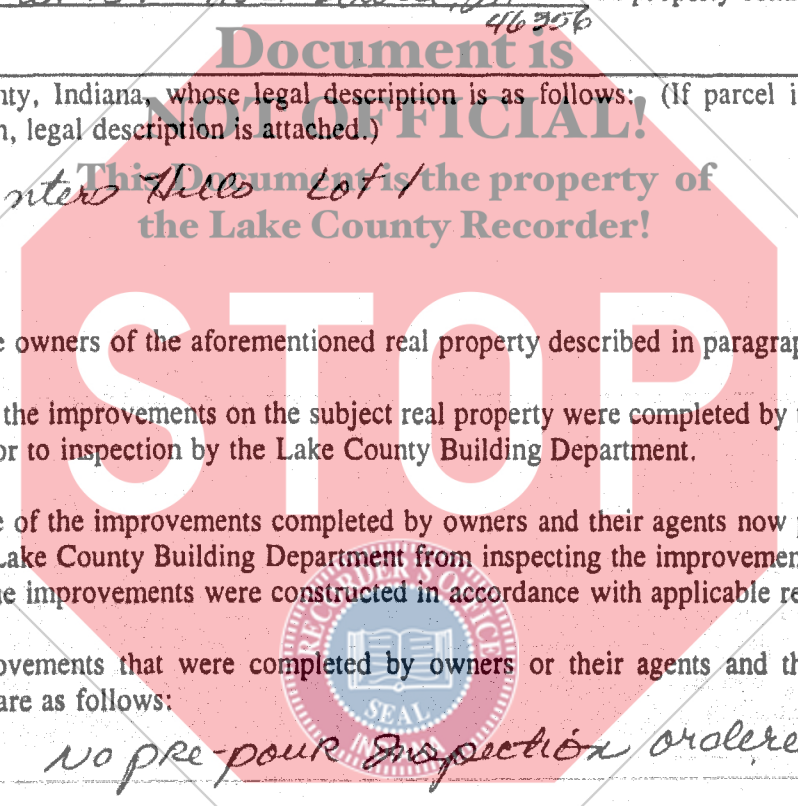
