Edinger Personal Trust dated September 20, 1990, do hereby grant, bargain, sell and convey to William A. Edinger and Rebecca Edinger, Husband and Wife, a 61.724% of the following described real estate in Lake County, State of Indiana, to-wit:

Lot 14 and Lot 15 Ridgeland Park First Addition, in the Town of Munster, as shown in Plat Book 31, page 88, in Lake County, Indiana.




