LEGAL DESCRIPTION RIDER

PARCEL I Part of the East 1/2 of the Northeast 1/4 of Section 28, Township 34 North, Range 9 West of the 2nd Principal Meridian, in the Town of Cedar Lake, Lake County, Indiana, described as follows: Commencing at the Northeast corner of said Section 28; thence North 89 degrees 27 minutes 41 seconds West (all bearings assumed) along the North line of said Section 28 a distance of 1109.37 feet to the Northwest corner of Utopia Business Unit No. 1, in the Town of Cedar Lake, as per plat thereof, recorded in Plat Book 35 page 106, in the Office of the Recorder of Lake County, Indiana; thence South 0 degrees 00 minutes 00 seconds East along the West line of said subdivision a distance of 35.00 feet to the point of beginning; thence continuing South 00 degrees 00 minutes 00 seconds East along the West line of said subdivision a distance of 250.00 feet; thence North 89 degrees 27 minutes 41 seconds West along a line parallel with the North line of said Section 28 a distance of 22.25 feet; thence North 00 degrees 00 minutes 35 seconds East along a line parallel with the West line of the East 1/2 of the Northeast 1/4 of said Section 28 a distance of 250.00 feet; thence South 89 degrees 27 minutes 41 seconds East along a line parallel with the North line of said Section 28 a distance of 22.18 feet to the point of beginning.

PARCEL II: The South 446.72 feet, EXCEPT the West 687.82 feet of the following described tract:
